2. Purpose of processing and legal basis:

Purpose: protection of life, health and property of individuals and the controller, and crime detection.

Legal basis:

The controller processes personal data of the data subject, namely recordings of the physical appearance and manifestations of a natural person, pursuant to Article 6(1)(f) of the GDPR and Section 13(1)(f) of the Personal Data Protection Act. The legitimate interest is the protection of the controller's property and employees, as well as the protection of life and health. In accordance with the principle of proportionality, the controller concluded that the protection of property, prevention of theft, protection of employees and other individuals, and assessment of occupational health and safety risks outweigh the privacy interests of the data subject. Audio/video recordings are retained for a maximum of 14 days under strict technical and organisational measures. After this period, recordings are deleted. Access is granted only to authorised persons designated by the controller.

3. Recipients or categories of recipients:

State authorities for fulfilment of the controller's legal obligations.

Law enforcement authorities and courts.

4. Data retention period:

Personal data obtained through the CCTV system are retained for a maximum of 14 days.

5. Rights of the data subject:

- Right of access to personal data.

As a data subject, you have the right to obtain a list of your personal data and information on how they are processed.

- Right to rectification of personal data.

We take measures to keep your personal data accurate, complete and up to date.

- Right to erasure of personal data.

You may request deletion of your personal data where legal conditions are met.

- Right to restriction of processing.

You may request restriction of processing under the conditions set by law.

- Right to object to processing.

You may object if you believe there is no valid legal basis for processing.

- Right to data portability.

Under certain circumstances, you may request transfer of personal data provided by you.

- Right to withdraw consent.

You may withdraw consent at any time where processing is based on consent.

- Right to lodge a complaint with the supervisory authority.
